In 2016 over \$4,042,000 in grants and scholarships were awarded. Discretionary grants including out of cycle and executive director grants totaled \$608,508. Scholarship awards from all funds totaled \$509.623 and included 326 new and renewal awards.

For nearly 70 years, the Springfield Foundation has been in existence to improve the quality of life in our area. In 2016 the Foundation decided to become involved in efforts to help revitalize downtown Springfield. They did this by committing \$500,000 over five years to SpringFORWARD. Summer Arts Festival

Shortly after sunrise, from mid-June through mid-July,

rows of lawn chairs begin appearing between the limestone cliffs of Veterans Park. For over fifty years, it has been the time-honored method for reserving a prime spot for a great evening of admission-free summer concerts, music and theater at The Summer Arts Festival!

In 1967, Jackson Wiley, then conductor of the Springfield Symphony Orchestra, gathered representatives from local arts organizations and non-profits to raise funds for a full month of concerts, plays, and children activities in three park venues: the Snyder Park band shell, the large shelter house across from the Snyder Park lagoon, and a portable platform stage against the cliffs in Cliff Park, now known as Veterans Park.

Incorporated in May of 1967 as the Springfield Arts Festival, Inc., the organization's board of directors changed their name to the "Springfield Arts Council" in 1971 and installed a permanent stage in Cliff Park, using volunteer labor and donated materials. The organization hired its first executive director in 1974 and the office for the organization was located upstairs at the equipment barn across from the lagoon in Snyder Park.

In the late 1990s, a multi-purpose building was constructed to the west of the Veterans Park stage to house dressing rooms, a small shop, and a concession facilities. But eventually, artists and audience needed more to make their experience at the festival more enjoyable. Renovations in Veterans Park, designed by internationally acclaimed architect Pietre Van Dyke, were completed in 3 phases, with the first phase including a restroom/concession building to the east of the amphitheater in 2003. The second phase, completed in 2005, included a new stage with a lighting canopy, a re-graded lawn seating area, lighting in the parking lot, and a technical productions building and deck at the rear of the amphitheater. In 2010, the third phase added a second restroom/concession facility and terrace to the west of the amphitheater.

After five decades of Festival concerts featuring hundreds of bands, artists and performers, the Summer Arts Festival is a community tradition, visited by annual attendees estimated at 80,000 people each summer. However, while the Festival is admission-free to attend, it is not free to produce, and financial support is critical to its operation and success.

The Springfield Foundation recognizes the value of the Summer Arts Festival to the community and provides support to Festival operations (such as crew and staff and behind the scenes equipment and maintenance.) Additionally, the Foundation provides necessary funding for ASL interpretation and accessibility of the Festival's musicals and family events to Springfield's hearing-impaired population. The Foundation also assists the Summer Arts Festival and other area cultural attractions with marketing opportunities to help spread the word about the cultural treasures in Springfield.

Because of generous donations to the Springfield Arts Council, "Pass the Hat" collections from attendees, sponsorships from local and area businesses, and annual grants and sponsorships from organization such as The Springfield Foundation, The Summer Arts Festival is accessible and available to everyone, and a truly unique event seldom found anywhere but Springfield!

Change in Bloom

With the move of the Ohio State University Extension Gateway Learning Gardens,

Master Gardener Volunteers have partnered with National Trails Parks and Recreation District to repurpose the former Snyder Park Golf course. With a concern for maintaining the long history of the Springfield Community, the gardens will incorporate historic artifacts from Memorial Hall and Snyder Park. Deeded as greenspace, the vision for the former golf course is to create a public garden in what will be a destination for the ever-increasing tourism base. Master Gardener Volunteers envision a high impact, highly visual experience that flows into plant collections and finally into a natural area for birdwatching and learning about various ecosystems.

In 2015, the Master Gardener Volunteers of Clark County began working on a landscape design master plan for the relocation. Fundraising efforts netted \$80,000 from the Master Gardeners of Clark County and the Springfield Port Authority donated \$50,000 to jumpstart the project. In 2015, the group planted their first Field Trial Research plot in their new location, as well as the Victory Garden, which produced 7,000 pounds of fresh fruits and vegetables, which were donated to the Second Harvest Food Bank.

With the completion of the master plan, development of the gardens will begin in phases. Groundbreaking for Phase I started in the spring of 2016 with the Early Ohio Settlers Garden, the regional Ohio State University turf research plot, improvements to the Victory Garden, and the site preparation for the Garden of Eatin'. Additional gardens to be added will include research plots and perennial gardens. A \$40,000 grant from the Spring-

field Foundation, which was approved in 2016, will fund the Feature Gardens. The garden is the grand entrance to the Snyder Park Garden and Arboretum and is a display of annuals, perennials, trees and shrubs encircling the center stage pavilion. Future phases will include a contemplative garden, perennial trials, tree and shrub collections, an outdoor education area, a tower to view the entire site and much more. All of the garden areas will be installed focusing on sustainable gardening practices and will be used to teach others how to be successful in their own gardens.

In addition, the Master Gardener Volunteers are partnering with The Hollandia Gardens Association in the development of the overall gardens. The Hollandia Gardens Association will be fundraising and designing areas that will include a maze and a children's garden. The groups will also be collaborating to create an accessible garden and an outdoor kitchen area. Springfield City School District Project Springboard Program

Project Springboard is a comprehensive family

literacy program dedicated to raising literacy levels of parents and increasing children's school readiness. There are an estimated 13,044 adults in Clark County who lack a high school diploma or its equivalent (U.S. Census Bureau). A January 2017 Goodling Institute Policy Paper highlights the relationship between parent's educational attainment and the next generation's literacy skills. There continues to be a demand for family literacy services as more children are underprepared to enter school and adults lack the skills and education necessary for employment to support their families. Research supports the many benefits of family literacy programs in addressing these issues.

Project Springboard integrates adult and parenting education, early childhood education and interactive literacy activities between parents and children. Families participate in intensive classroom, home-based and support services. Adults increase their basic skills, prepare for the GED test, transition to employment and postsecondary education and partner in the education of their children. Children develop early language skills and reading readiness and parents are supported in their role as their child's first teacher.

Project Springboard began operation locally in 1996 through a federally funded Even Start grant, which supported these efforts until it was eliminated from the federal budget in 2012. As government funding dissolved, private foundations were explored to continue offering services to the most educationally and economically disadvantaged residents of Clark County. In 2012, The Springfield City School District was one of seven chosen from over 600 applicants nationally to receive a Barbara Bush Foundation for Family Literacy Grant. To meet the requirements of this grant, a partnership was formed with The Springfield Foundation. This has played a vital role in the continuation of the program.

Project Springboard works toward breaking the cycle of poverty and low literacy in our community through generous support from The Springfield Foundation, The Wilson-Sheehan Foundation and The Dollar General Foundation. There is no better time than now to talk about health, as the 2017 county health rankings are hot off the press, placing our county at 73rd place out of 88 for health outcomes. As a community this is a challenge we face and imperative that we embrace. We can and should rely on each other's skill and expertise to fight this war against premature deaths (predominantly due to drug overdose), lack of access to health care, poorly managed chronic conditions, adult obesity etc., which are the very factors that dragged our ranking south.

In early fall of 2016, as part

of The Community Health Assessment conducted by our local Health District, Congestive Heart Failure was identified as one of the most common causes of hospital admissions in individuals over the age of 65 and the lack of access to primary care services for such individuals played a significant role on their health outside the hospital and increased readmissions. A need for a Chronic disease program was recognized. Chronic Disease Programs are usually multi-component efforts that include coordination of health services by multidisciplinary teams of health care professionals, patient self-management and patient education. Chronic disease management programs have been shown to improve health outcomes in patients with diabetes, heart failure, hypertension, COPD and anxiety and depression.

Rocking Horse Community Health Center, Springfield Foundation, Springfield Regional Medical Center, Community Mercy Homecare and other ancillary services, joined hands as part of a task force that emerged out of the Community Health Improvement Plan. Patients with Heart Failure that do not have a primary care provider were recognized to be the defined population to improve outcomes. The goal is to reduce hospital admissions while keeping these patients healthy and functional at home. With care coordination as the crux of the model. Rocking Horse was granted funding by the Springfield Foundation to invest in coordinating services that would link individuals with Heart Failure to all the needed services; pharmacy, primary care, home care, dietary, nursing, etc. If transition of care between different settings like hospital and home can be done in a timely and effective manner, health outcomes fair better. This joint venture between various organizations is a good example of a community coalition.

Since the inception of the transitions of care clinic early this year, referral process for any patient who is being discharged from the hospital with Heart failure to establish care at RHCHC has been streamlined alongside of physician, nursing and pharmacy services being provided on-site and home care services being initiated when necessary. The measures of success towards established goals will be tracked and members of the coalition as well as the community will be kept informed.

In conclusion, the success of this community effort should serve as a motivator for entities from various disciplines to come forward to work towards a common goal of making Clark County a happier and healthier place to live.

Second Harvest **Food Bank**

Food Insecurity in Clark County

Food security exists when all people, at all times, have physical and economic access to sufficient safe and nutritious food that meets their dietary needs and food preferences for an active and healthy life. Unfortunately 16.8% of those in Clark County face food insecurity which equates to 22,410 people. Of those, 8,100 are children. The child food insecurity rate in Clark County is 25.5%, which is above the state and the national average. Annually, Second Harvest Food Bank (SHFB) secures nearly six million pounds of food or over 5.5 million meals, but it isn't enough. We still have people struggling to put food on their tables.

Who faces food insecurity and what does it mean? Food insecure households are not necessarily food insecure all the time. Food insecurity may reflect a household's need to make trade-offs between important basic needs, such as housing or medical bills, and purchasing nutritionally adequate foods. Over 60% of those who use Second Harvest Food Bank's direct service programs or receive food from our member agencies have jobs. Many have two part time jobs and are simply trying to make ends meet from month to month.

Hunger and malnutrition have devastating effects on our elder's ability to live independently in their homes, increasing the incidence of adverse health conditions, limitations in daily activity and disabilities. Over 17% of those who walk through our doors are seniors, individuals over the age of 60 who have incomes below or at 200% of the federal poverty guideline. Each month, through our Commodity Supplemental Food Program, we distribute nearly 1,100 food boxes to seniors, and we have a waiting list of over 200 individuals to join the program.

Although food insecurity is harmful to any individual, food insecurity is particularly devastating among children due to their increased vulnerability and potential for long – term consequences. Several studies have demonstrated that food insecurity impacts cognitive development among young children is likened to poorer school performance. In 2016, due to the high rate of childhood food insecurity rates in our community, SHFB commenced a



Weekend Power Pack Food Program. At this time, we distribute 780 bags weekly to students at Clark Preschool and Fulton Elementary School. When in school children receive 2 nutritious meals, but during the weekend often face the issue of not having food in their homes. Through support of the Springfield Foundation and other local foundations, we have secured funds to provide the program through the end of the 2016-2017 school year, but are currently raising funds to continue to program.

Second Harvest Food Bank is proud to serve our community. Whether it is through our direct programs, which include an on-site pantry that operates 5 days a week serving over 1500 individuals monthly, our mobile pantry that takes food out 15 – 20 times a month to food deserts where there are no stores and a lack of transportation, or our senior and children food programs. A large portion of our time is dedicated to working with our 65 member agencies by conducting inspections of their facilities to ensure food is properly handled and stored. To make sure they deliver food in a respectful and non-discriminatory manner.

While it is true that food insecurity affects the homeless and those struggling with substance abuse, the majority of those impacted are people you know. The faces can take on the appearance of your neighbor, family member, or co-worker. Food insecurity can be solved, and it can be done so through time commitment serving the community, financial support, and talking with your legislators about laws and policies that affects the workforce, seniors. children, and our communities.

There have been many exciting things happening at the Clark County Fairgrounds

in the past year. One of which, is being made possible by a \$25,000 grant from the Springfield Foundation. Our Lake Development Project, a plan to turn a 115acre former gravel pit turned lake, into a widely known water sports venue, is in its beginning stages. Because of the Springfield Foundation's generosity, the Fairgrounds has entered into an agreement with a motor-sports company to research potential water sports events and pricing quotes and a strategic plan has been developed by a surveying and engineering firm. Next steps on the project include corporate and funding partnerships for the finishing stages of phase one.

The ultimate goal is to host a series of water sports events including: on the water boat shows, Formula series boat races, solar boat races and wave runner races, as well as fishing tournaments. The Fairgrounds is a major component in the tourism industry for Clark County and the development of the lake will only enhance our draw. Currently, events held at the Fairgrounds account for approximately 70% of all tourism traffic in our county.

The Fairgrounds is considered an "up and coming" venue in the powerboat industry and has been the topic of conversation at the American Boat Association's annual meeting, as well as the Indianapolis and Los Angeles trade shows.

The Lake Development project also brings additional resources to the community. The design of a cross-country course will begin around the lake as soon as the weather permits. This course will allow for multiple schools to host local, county, regional and hopefully state cross country competitions. A partnership with CTC and GISA Stem School has been established to help construct the course. Working with and supporting local youth is our mission at the Agriculture Society and these partnerships could not align any better. A new fire barn will be built by



CTC's carpentry class and will be completed by the 4th of July fireworks celebration. An additional \$12,000 grant was awarded to the fairgrounds from the Robert M. Farish Family Building Trades Fund held at the Springfield Foundation. This fund provides grants for educational and training opportunities in the building trades industry for resident of Clark County. Through this grant, CTC will also be constructing a large shelter house located near the lake to be utilized for events.

Planned Giving

Giving can help make the world a better place for ourselves, our children and future generations. Additionally, a well-structured charitable plan can provide benefits to the causes you care about for generations to come. What is the best way you can give?

Q. What is a direct gift to charity?

A. You can make an outright gift during your lifetime or leave it through your Will as a bequest. Donations to charity often include various types of assets, such as cash and securities, as direct gifts. A gift to a capital campaign is one example of a popular type of direct gift. However it is often easier to leave these types of assets to a community foundation which in turn will provide the gift to your choice of charity for the specific amount and year you choose depending upon the value of your original donation.

Q. What are the estate planning implications of direct gifts?

A. If you make a direct gift, it may lower your estate taxes by removing the asset and its appreciation from your estate. For gifts made at death, there could be an estate tax deduction equal to the amount of the gift.

Q. When should you consider using a professional trustee such as the Springfield Foundation?

A. It may be possible for you or a family member to act as trustee of a trust that you establish for charitable gifts. However, most individuals do not have the time or expertise to effectively perform the duties and responsibilities of a trustee. Charitable trusts and foundations often have additional administrative and investment management requirements that, if not performed correctly, may jeopardize their charitable and financial benefits. I believe your philanthropic dollars should be managed and allocated as strategically as the rest of your wealth. Thus, a foundation such as The Springfield Foundation is a better management choice for the gifts during your life and thereafter.

Q. What is the minimum for giving funds to a foundation?

A. Many individuals think gifts to a foundation are only for the rich. I have advised many clients to donate to the Springfield Foundation as a way to remember or honor a loved one. The foundation will work with you to establish a fund today or a fund for the future. You can make donations over several years in order to meet minimums for the different programs There are so many ways to serve our community and the Springfield staff can help you with suggestions. Some of my favorites include scholarships for students going into a specific field such as agriculture for the client who is a farmer or education for the donor who is a teacher.

As your assets grow, so does your ability to support the people, institutions and causes that add meaning to your life. In all likelihood, you and your family give generously and are routinely called upon to do more. You may have a very precise idea of what you hope to accomplish through these philanthropic efforts, or you may be in the earlier stages of exploration. Either way, The Springfield Foundation is here to provide you with the support and advice you need to define your philanthropic goals, maximize the impact of your contributions and create an enduring legacy.

Investment Overview

A majority of the Springfield Foundation's endowment funds is invested in a "Balanced Pool" portfolio, which is structured for long-term total return. To provide diversification and to reduce overall risk, the investments are divided into carefully defined asset classes. Assets are invested by professional money managers hired by the Foundation through a competitive process. The investment performance of each money manager is monitored by an independent investment consultant retained by the Foundation and overseen by the Foundation's Investment Committee. A list of our current investment managers is available at the Springfield Foundation office.
