Dear Friends.

The year 2020 began with ideas and big plans. The list included a focus on Diversity, Equity, and Inclusion, a redefinition of our role in Springforward, and to ensure that we could be nimble and responsive to community needs without compromising the important grantmaking process. So, we began with some goals, but there were a few things we did not plan.

We did not plan for an announcement on February 2nd, that a major grocery chain would be closing a location in the southside of Springfield, effective March 4th. This action followed the closing of two other major groceries in the preceding years, creating a serious dilemma for many residents in our southside neighborhoods and community. The Springfield Foundation, along with valued partners, assisted as a responsive provider of time, talent, and funds to assist with efforts to make healthy food choices available to help lead efforts for an orderly transition.

Also, our Foundation did not plan for the implications of the Covid-19 pandemic. In early March, our Governor announced that the first cases of Covid-19 had appeared in Ohio. At that time, he announced the closing of selected businesses, effective March 15th. Schools and social events were ultimately sidelined or changed, and many people and our economy began to suffer the consequences. Our lives were changed and for many people, they have been changed forever. We were concerned about our employees, how we would conduct business, the state of our investments, and the new technology it may take to sustain a viable responsive organization. Our staff deserves a sincere thanks for their dedication and resilience during a very difficult year. From a personal perspective, at the beginning of 2020, I had never used Zoom. Today, it has been the basis and means for every meeting of the directors, committees, and valued partners. We do miss the contact and personal connection with our friends and community, but we learned to adapt by using the technology that we had available.

As we leave 2020 behind, we have the memories of a responsive year, a year filled with pandemic confusion, and a year that moved important work forward. It was also a year that saw several members of the Board completing their term obligations. We will miss the excellent and valued services of Tammi Angle, Tom Loftis, and Dan O'Keefe. Even though their experience and talent will be missed, we know that they will remain involved in the important work of our community. To help ensure that our work continues, we were pleased with the addition of new Directors. These new servant leaders include Raphael Allen, Sharon Frandsen, and Jermain Maynard. We give thanks to all of those from our past and for all of those who are willing to serve as we strive to "make a difference".

In many ways, this has been a year like "no other year". Despite many challenges, the Springfield Foundation, through the leadership of Ted Vander Roest, complemented by a talented and dedicated staff, we continued to make a difference. In 2020, we continued as a catalyst for philanthropy and, with \$3.73 million received, we had a very successful year in the gift development.

Jefferson Street Oasis Community Garden



If you have never seen Jefferson Street Oasis (JSO) Community Garden please come and visit. It is located at 1100 West Jefferson Street. JSO is unique because it is an allotment style garden providing various sized plots to mostly residents living in the areas affected by food insecurity and lack of nearby grocery stores. Gardeners have the desire to plant, tend, harvest, prepare and preserve fresh produce for themselves, their family and friends.

Excess is donated to local food outreach ministries. Since its first year in 2012 when there were only six to eight plots; it has grown now, ten years later, to 75 plots with 85 adults tending just the vegetable gardens.

In addition it also has an herb, pollinator and children's garden; along with a poly house growing fresh greens year around. We have also partnered with Cheryl Fitzgerald who has brought her pasture raised chickens to the garden to educate all and provide farm fresh eggs. This all sits on a 4.8 acre parcel solely owned by JSO which presently has about 2.5 acres under cultivation so there's room to grow.

2020 at Interfaith Hospitality Network of Springfield

What started out as a normal year in the IHN shelters, quickly turned upside down when COVID took over our lives. Following the CDC, State, and Clark County Health Department rules and regulations, we were forced to close our congregate shelters and move the guests into local motels. The usual number of guests served between the two shelters (one for families and single women and one for single men) is 72 individuals per day. As the pandemic progressed and individuals started losing their employment and housing, the number of those seeking shelter swelled by 250% and on to 350% more individuals than normal.

The IHN Case Managers continued to assist our guests via phone or virtual appointments. 85% of those served from March, 2020 through December 31, 2020, accessed permanent housing. IHN provided all hygiene and PPE needs, coins for laundry, bus passes and gas cards for those with vehicles. Through partnering with Second Harvest Food Bank and the National Guard, we provided food for breakfast and lunch; and working with several local restaurants we delivered hot meals each day for dinner.

Serving the large number of individuals has necessitated increasing staff, some working from home and others working different and long hours. During 2020, IHN served 487 individuals, 159 of those were children. 2021 continues much like 2020, still housing large numbers of individuals in motels and providing all of the same services.

I had been living in the same house for over five years. I recently lost my job, which decreased my monthly income. I'm still receiving social security benefits. However, due to the loss in income, I became behind on my rent. I attempted to advocate for myself to remain in housing, however, after multiple attempts I gave up.

The humiliation that I felt for not only being homeless but also living out of my car, was great. I felt so alone and betrayed. I believed falling on hard times would open the door for family to get involved and help out. My thinking was way off. There was no help for me from any of my family.

I decided to stop feeling sorry for myself and I made a call to IHN. I called on February 2nd, and was placed in shelter. I felt so relieved that I no longer had to stay in my car. When I entered the hotel, I again felt embarrassed because I was there. I saw a staff person who I've known for a long time, and that made me feel so low. However, she reassured me that they were there to help and not judge anyone.

Help—means to make things easier for someone. Help is just what IHN provided me. I was connected to a case manager named Penny and she referred me to HCRP. Immediately, both Case Managers worked guickly to assist me with housing.

On the 24th of February, I obtained housing and housing assistance. The appreciation I feel is beyond words. It is my hope that one day I will be able to pay it forward. I pray that other clients are just as successful as I was. I pray that the Case Managers realize how much of a blessing they are.

2020 CultureFest **Takes Book Club Form in Pandemic**

In pandemic times when gatherings were canceled or postponed, organizers of Springfield's annual CultureFest celebration came up with a cozy and socially-distant alternative: curling up with a good book.

CultureFest is an annual celebration of community diversity that takes place on the City Hall Plaza. Each September, hundreds turn out for the activities, music, entertainment and global cuisine. But, when COVID-19 cast a cloud over the festivities, organizers put their heads together to form a safe alternative.

"The focus remained on understanding the importance of diversity in the community and highlighting unity," said Shannon Meadows, City of Springfield Director of Community Development. "We wanted to observe the principles of CultureFest, celebrate diversity, and learn about ourselves and others; while keeping the community safe."

That's when the CultureFest Committee opened a new chapter. CultureRead.

"The idea was to launch a community book read, choosing titles written around racism, white privilege, and systemic bias," said Cheryl DeGroat Dover, Minority Business Development Coordinator for the City of Springfield Community Development Department.

The Committee, comprised of members of the CultureFest Steering Committee, Human Relations Board, and Springfield's Global Education and Peace Network; along with representatives from higher education, interfaith community, and local foundations first settled on a topic, antiracism.

While a stack of books on the topic were available, the Committee settle on three titles. three levels of awareness and three phases of the process. The titles were:

"How to be an Antiracist" by Ibram X. Kendi "Me and White Supremacy" by Layla Saad "White Fragility" by Robin DiAngelo

Participants were asked to choose the titles based on which spoke specifically to their religious tradition or culture about addressing antiracism. Participants were given guidance about their "on-ramp," – where he or she was positioned in their journey based on their own experiences and beliefs:

- I want to learn more. I'm just starting to think about this.
- I understand there are problems with racism, but I don't see myself as racist.
- I'm very concerned about systemic racism and want to take action to dismantle it.

A workbook was made available, participants chose their titles and some checked in for video podcasts to talk about what they learned. Committee member Jack Legg lent his radio personality voice and skills to the podcast, broadcast in three phases: Beginning Thoughts; Midway Thoughts; and Final Thoughts.

For the video podcast series, the following participants spoke about their book selections:

- · Pastor Adam Banks, First Baptist Church, "How to be an Antiracist"
- Suzie Carey, Springfield Foundation, "White Fragility"
- Rob Rue, Springfield City Commissioner, "Me and White Supremacy"

Of his participation in CultureRead and his selected title. Pastor Banks said there were several things that spoke to him directly and several things that could be beneficial to all people.

We can all, everyone, no matter our background, no matter our ethnicity or race...can all be either racist or antiracist, **99** said Banks during the video podcast.

Investment **Overview**

A majority of the Springfield Foundation's endowment funds is invested in a "Balanced Pool" portfolio, which is structured for long-term total return. To provide diversification and to reduce overall risk, the investments are divided into carefully defined asset classes. Assets are invested by professional money managers hired by the Foundation through a competitive process. The investment performance of each money manager is monitored by an independent investment consultant retained by the Foundation and overseen by the Foundation's Investment Committee. A list of our current investment managers is available at the Springfield Foundation office.
